To Whom it may Concern,

The Devens Enterprise Commission (DEC) inspects septage hauler trucks and provides them with a license to conduct business in conjunction with Devens Utilities. In order to better address the traffic concerns of our neighbors on Walker Road in Shirley, the DEC, in conjunction with Devens Utilities, is taking the following steps:

- At the time inspections of septage hauling trucks are conducted and licenses to do business at the
 Devens Waste Water Treatment Plant (WWTF) are issued, a preferred route map will be provided
 to the hauler showing that they are to access the plant from the south via Front Street in Shirley.
 This map and a complaint process (see below) will be posted on the DEC web site.
- Devens Utilities will provide similar written notice to all of its clients in addition to those requiring septage haulage licenses.
- The DEC will establish a complaint process in conjunction with Devens Utilities.
- The DEC will only accept written complaints, preferably using the complaint form that can be
 downloaded from the DEC web site (www.devensec.com). Complaints must include the date of the
 occurrence, the time and any identifying information such as the name on the truck.
- The DEC will pass this information to Devens Utilities and United Water, the Devens subcontractor
 that operates the Devens WWTF, who will check it against their delivery logs. If the incident is
 confirmed, this will count as a confirmed complaint and written notice will be sent to the offender
 by the DEC and Devens Utilities.
- If three confirmed complaints are received by the DEC, the violator's license will be revoked and may not be reissued for the following year.
- There will be an educational period during which notice of the preferred route to access the WWTF is given to the licensed haulers.

It is important to us to respect the impact of these vehicles on the local roads that service our facilities. Your cooperation on this matter will allow us to maintain the operations of these facilities and good relationships with our neighbors. We appreciate your assistance and welcome any questions you may have.


